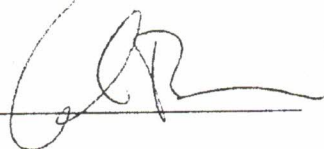

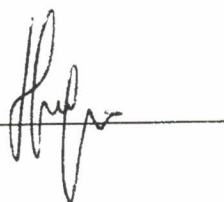

REDELIVERY CERTIFICATE

THIS REDELIVERY CERTIFICATE is dated 07th of Nov 2008, (the "Redelivery Certificate"), by and between

MALC Lease One Limited ("Lessor") represented by MALC Management Company

and

Myair.com S.p.a ("Lessee")

WITNESSETH:

WHEREAS, Lessor and Lessee have heretofore entered into aircraft lease agreement dated 26 day of May 2006 as novated in favour of My Air .COM S.r. L pursuant to the Aircraft Lease Novation and Amendment Agreement dated 18 January 2007 (the "Lease"), MALC Lease One Limited hereby acknowledges that at Orio al Serio Airport (BGY) on 06th of Nov 2008, the technical condition of a A320-231 Aircraft with Manufacturers Serial No 338 (the "Aircraft") is satisfactory to, and accepted by, the Lessor. My Air has delivered the Aircraft, to Lessor at Lasham Airport, United Kindom, and Lessor has accepted such delivery, and that the Aircraft has been redelivered in accordance with, and in a manner which fully complies with, the requirements of the Aircraft Lease Agreement between Lessor and Lessee dated May 26th 2006 as amended by the Termination Letter dated November 3rd 2008 ("Termination Letter"). The amended redelivery Conditions are attached herein in Appendix VI.

The Lessor confirms to the Lessee that as at the time indicated above the Aircraft and the Aircraft Documents are in accordance with the Termination Letter.

Lessor has authorized the transfer of funds as per Termination Letter dated November 03rd 2008 and Lessor shall provide Myair.com with the copy of the transfer details on November 09th 2008.

NOW, THEREFORE, in consideration of the premises, and pursuant to Clause 19 of the Lease, Lessor and Lessee hereby agree as follows:

1. Definitions

Unless otherwise defined herein, all capitalized terms used herein shall have the respective meanings given them in the Lease.

2. Redelivery and Acceptance

Lessee hereby delivers and returns to Lessor, and Lessor hereby accepts from Lessee under the provisions of the Lease and the Termination Letter



8. Governing Law

This Redelivery Certificate shall in all respects be governed by, and construed in accordance with, the laws of England. Subject to the relevant Clause of the Lease, the parties hereto agree that the courts of England are to have jurisdiction to settle any disputes which may arise out of this Redelivery Certificate.

CONSIGNMENT AGREEMENT

- This Consignment Agreement (this "Agreement") is dated as of November 5, 2008, by and between MALC Lease One LTD (MALC), a company incorporated under the laws of Bahamas, whose registered office is at MB & H Corporate Services Ltd., Mareva House, 4 George Street, Nassau - Bahamas ("Consignor"), MALC Management Company LTD (MALC-MC), a company incorporated in the Bahamas with its registered office at MB&H Corporate Services Ltd., Mareva House, 4 George Street, Nassau, Bahamas ("Consignor Agent"), and GA Telesis, LLC, a Delaware limited liability company with its principle place of business located at 5400 NW 35th Ave, Building 16, Fort Lauderdale, FL 33309 USA ("Consignee").

BACKGROUND

Consignor is the owner of the aircraft and engines specified on Schedule A (collectively, the "Consigned Goods", and where applicable, the "Aircraft", "Airframe", "Engines" or "Parts").

Consignor Agent, in its capacity as agent, will act on behalf of Consignor with respect to this Consignment Agreement, in fulfilling all of its obligations, including without limitation, with respect to the management and oversight of the Consigned Goods herein stated.

Consignee is in the business of marketing aircraft, aircraft engines, aircraft parts, components, and material substantially similar to the Consigned Goods, and Consignor/Consignor Agent would like to engage Consignee to market for lease, sale or exchange, and to manage and repair the Consigned Goods in accordance with the terms and conditions of this Agreement.

AGREEMENT

A. Engagement; Sales.

1. Sales. Consignor/Consignor Agent hereby engages Consignee on an exclusive basis to receive, maintain in inventory, market and sell the Consigned Goods in accordance with the terms and conditions of this Agreement. Consignee hereby accepts such engagement and agrees to use its commercially reasonable best efforts in its performance hereunder, including the sale of the Consigned Goods at then current market terms and conditions. All Consigned Goods leased, sold or exchanged by Consignee under this Agreement shall be referred to as "Sold Goods" and the parties acquiring Sold Goods shall be referred to as "Customers."

2. Delivery. Consignee will take possession of Consigned Goods at 15 Cobham Road, Ferndown, Dorset BH21 7PE, United Kingdom (the "Delivery Location") on one or more dates specified in Schedule A (each a "Delivery Date"). If the Delivery Location
